

TERMS OF USE

INTRODUCTION

1.1 Welcome to the [mymotorpal.com.my](https://www.mymotorpal.com.my) website and/or the My Motor Pal mobile app (the “Online Platform”). These Terms of Use govern your access and use of the Online Platform and the use of any services, information and functions made available by us at the Online Platform (“Services”). Before using this Platform or the Services, you must read carefully and accept these Terms of Use and all other terms and conditions and policies pertaining to the use of the Online Platform and/or the Services (collectively referred to as “My Motor Pal Terms and Conditions”) and you must consent to the processing of your personal data as described in the Privacy Policy set out at <https://www.mymotorpal.com.my/privacy-policy/>. By accessing the Online Platform and/or using the Services, you agree to be bound by My Motor Pal Terms and Conditions and any amendments to the foregoing issued by us from time to time. If you do not agree to My Motor Pal Terms and Conditions and the Privacy Policy, do not access and/or use this Online Platform and/or the Services.

ARBITRATION

8.1 Any controversy, claim or dispute arising out of or relating to these Terms of Use and/or other My Motor Pal Terms and Conditions or the breach, termination or invalidity thereof shall be referred to and settled by arbitration in accordance with the Arbitration Rules of the Asian International Arbitration Centre (“AIAC”) held in Kuala Lumpur, Malaysia. The arbitral tribunal shall consist of a sole arbitrator who is legally trained and who has experience in the information technology field in Malaysia and is independent of either party. The place of arbitration shall be Malaysia. Any award by the arbitration tribunal shall be final and binding upon the parties.

8.2 Notwithstanding the foregoing, My Motor Pal reserves the right to pursue the protection of intellectual property rights and confidential information through injunctive or other equitable relief through the courts.

TERMINATION

9.1 In addition to any other legal or equitable remedies, we may, without prior notice to you, immediately terminate or revoke any or all of your rights granted under these Terms of Use and/or other My Motor Pal Terms and Conditions. Upon any termination of these Terms of Use and/or other My Motor Pal Terms and Conditions, you shall immediately cease all access to and use of the Online Platform and/or Services and we shall, in addition to any other legal or equitable remedies, immediately revoke all password(s) and account identification issued to you and deny your access to and use of this Online Platform and/or Services in whole or in part.
